3. The Artist consents and expressly agrees that OSA may display the artwork in the said OSA building. The Artist also agrees that photographs may be taken of said artwork by OSA to be used for publicity purposes including social media.
4. The Artist agrees that their work is original to the artist and does not infringe upon or violate the copyright of others. For a juried show, the artist agrees that their work was not a class project.
5. By signing below, the Artist specifically expresses his or her understanding and agreement that OSA carries no insurance or other coverage against damage, destruction, theft, or other loss of or to the artwork while on OSA premises. OSA also does not have and does not accept any liability for and does not give any guarantee against any such damage, destruction, theft, or other loss to the artwork. OSA does not have and does not accept any liability for damage, destruction, theft, or other loss during delivery to or removal from OSA premises by the Artist or any other persons **The Artist further agrees to save and hold OSA harmless in the event of any such damage, destruction, theft, or other loss.**
